Extended Hands Pantry is a faith-based, volunteer-driven, nonprofit organization with a two-fold purpose. To provide groceries and other household items to those in need, and to provide tutoring for children in low-income neighborhoods.

Our mission: Serve our area families and individuals with compassionate acts of love. Encourage, educate, and nourish our children as a servant-hearted expression of Jesus Christ.

MOBILE FOOD PANTRY

Our mobile food pantry at Lighthouse Church and School continues to grow. When we compare this past fiscal year to the previous fiscal year, the pantry has grown 40% and our food costs have climbed 65%! Inflation has been the greatest driver for both the number of people who come for food assistance and our expenses to meet the demand.

We are proud that our pantry remains committed to providing culturally appropriate foods to underserved communities. Our shoppers are primarily Latino, but also African American, and Middle Eastern.

Total number of families served -- 3709 This includes children (6,658), adults (10,356), and seniors (1,082).


TUTORING AND EDUCATIONAL SUPPORT

The tutoring program was paused for the past year due to Covid. Although that will finally start back up again this school year. We also provided school supplies for 300 school-aged children at the Northport Apartments and Packer Townhouses. We are pleased to report that the afternoon snack / meal at Northport and Packer served 7,371 snacks over the last school year! It's well-known that hungry kids can't learn and having something to eat at their afterschool program makes a huge difference in their ability to settle down and work on reading and math. DIRECTOR'S STATEMENT

Fiscal year 21–22 was a challenging year for Extended Hands Pantry. Operating out of a refrigerated truck in the Lighthouse School parking lot, in snow, in rain, in single digit weather and in tropical heat, our mobile pantry successfully served many families throughout the last year.

Although open to anyone, the pantry primarily serves Latino families who are drawn to the bilingual school and church. We worked hard to attract funds for purchasing food products with which our families feel comfortable. Often, we must purchase those products retail or wholesale. Our families also prefer fresh vegetables, fruits and dairy products, all difficult items to deliver safely on a truck in uncertain weather.

At the same time, we are working with Lighthouse Church and School to plan an indoor extension to their building that would be the permanent home of the pantry. It is scheduled to be ready for occupancy at the end of the year.

In 2022 usage of our food pantry increased dramatically as families' budgets were shattered by inflation.

The new indoor pantry space will allow us significant expansion of services and enhanced food safety. It will result in a space that truly serves the needs of our families.
